The Angler FB-G2 lets you attach the Godox AD200 and AD200pro flash heads to your Angler FastBox. When the adapter is securely mounted, you can take advantage of the many accessories that are available for the FastBox, such as a 40° grid, diffusers, and color gels.

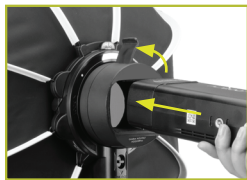
Attaching the FB-G2 and Flash to the FastBox

Important! If your AD200 or AD200pro flash has a diffuser already installed on the end of the flash head, remove the diffuser before proceeding with the instructions.

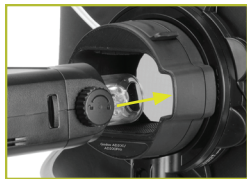
Line up the alignment dots. Insert the adapter, and rotate clockwise until it clicks in place.



Unlock the flash lock, and insert the flash into the FB-G2 adapter.



When using the Godox AD200pro with the bare bulb flash head, make sure to orient the light so the locking ring is aligned with the FB-G2's notch.



Make sure the flash is fully inserted into the adapter, and close the flash lock.



Removing the Flash

Unlock the flash lock and carefully remove the flash from the adapter.



Removing the FB-G2 Adapter

Pull down on the release latch, and twist the FB-G2 counterclockwise to remove it from the FastBox.
