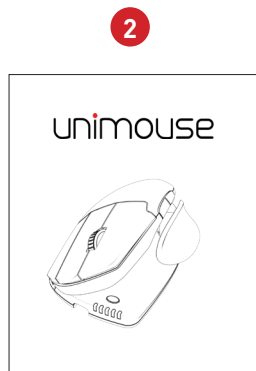

Connecting to a Computer

Plug the wireless receiver or the charging cable into the computer's USB port. Allow your computer a few seconds to automatically install.



Middle Click to Double Click

Unimouse comes with middle click as the default setting. To change the middle click function to double click, hold down the cursor speed button and the middle click at the same time. To switch back, repeat the same command.

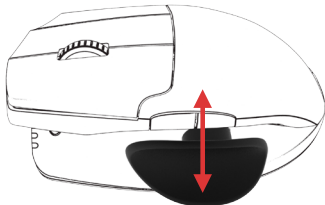

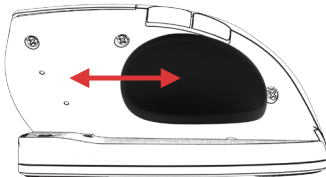
Cursor speed (DPI)

Adjustable Features

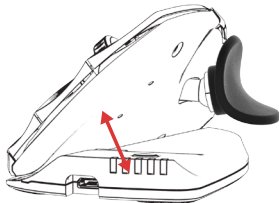
Adjust thumb rest in and out to accommodate hand size



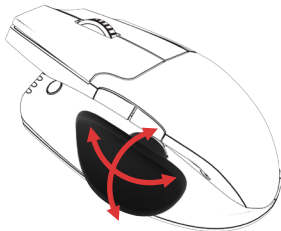
Slide thumb rest side to side to accommodate thumb length



Adjust tilt for desired angle

Change cursor speed

Press the Cursor Speed button to cycle through cursor speeds. There are ten speed selections ranging from slow (800 DPI) to fast (2800 DPI). Speed is indicated by the LED lights as shown.
